2. The Cooperator agrees to the following:

3. On the contracted areas, the cooperator further agrees:

- (a) to protect all habitat from unauthorized activities such as grazing, mowing, shredding and chemical application;
- (b) to not use pesticides, except as authorized by a NGPC representative and control noxious weeds in accordance with Nebraska statutes;
- (c) to recognize that retaining both the seeded and volunteer plants is an important component of the program for wildlife and hunting;
- (d) that all public hunting and trapping activities will be limited to foot-traffic only, unless agreed upon designated trails exist;
- (e) to permit NGPC representatives access to the property and CRP contract information necessary for inspection and annual payment purposes;
- (f) to certify that some of the enrolled acreage consists of land enrolled in CRP or WHIP as appropriate;
- (g) to ensure that walk-in hunting and trapping access is provided during all legal hunting seasons;
- (h) to allow the use of portable temporary blinds and tree stands if appropriate;
- (i) that renters or lessees of property may only enter into agreements if such rights are granted by the owner or with owner consent;
- (j) that change in ownership of the contracted area shall terminate this agreement.

4. The NGPC further agrees to provide added law enforcement presence, payment upon satisfactory completion of this Contract, signs and designated parking areas as needed.

5. Either party upon 30 days written notice may terminate this Contract; a pro rata payment based on the primary hunting period will follow.

6. Modification to this Contract must be made in writing and signed by both the Cooperator and the NGPC representative.

7. Program payments may be modified if the contracted area is hayed or grazed through either emergency or managed conditions.

8. Program payments are made in March following the primary hunting seasons or upon completion of the contract agreements.

9. If program funds are discontinued, the NGPC may void this contract.

10. Failure on the part of the Cooperator to comply with the terms of this Contract shall be cause for Contract cancellation.

11. This writing and its attachments contain all the agreements between the parties.
